# Hong Kong ICT Awards 2015: Best Innovation Award

## Eligibility 參賽資格

- The Award is open to any locally registered company or organization or individual who possess valid Hong Kong Identity Card, excluding full-time undergraduate students.
- 2. A significant part of the design, research and development of the submitted ICT product/service must come from resources in Hong Kong.
- 3. Entrants must have the intellectual property right and legitimate right to the use of the ICT product/service mentioned in the application.

### Rules and Regulations 參賽規則

- 1. The submitted ICT product/service should have been launched and in operation at the time of entering the competition.
- The same application is only allowed to be submitted to a maximum of ONE award stream among all the award categories (except Best ICT Startup Award), and applicant should declare that in the application form. Any application found to enter into more than one award stream will be disqualified and any award / certificate granted will be withdrawn.
- The winning entries of Gold / Silver / Bronze award in the previous years of Hong Kong ICT Awards are not allowed to enter the Awards again, unless there is significant change or enhancement in the product/service.
- 4. Entrants providing false information or failing to provide sufficient or genuine information will be disqualified.
- 5. Short-listed applicants are required to attend an interview with the Panel of Judges.
- 6. The Organiser at its sole discretion reserves all the rights to modify the rules and criteria of the Award. The Organiser also reserves the right to withdraw, or revoke any award that has been made or presented.
